# Information about the processing of personal data in connection with the use of the Edenred Dovolenka holiday voucher

## 1. Data Carrier

The data carrier is Ticket Service, s.r.o., registered address Karadžičova 8, P.O. Box 21, 820 15 Bratislava 215, Company ID (IČO): 52005551, registered in the Commercial Register of the District Court Bratislava I, Section Sro, File no. 132404/B (hereinafter referred to as Ticket Service).

## 2. Processing of personal data for individual purposes

### 2.1. Processing of personal data for the usage of Edenred Dovolenka holiday card

#### 2.1.1. Processed personal data

Ticket Service processes the following personal information: name, surname, address, company name (employer), employee's personal number, transaction details (payments made, funds received), card balance, data included in complaints and related to complaint handling.

#### 2.1.2. Purpose and legal basis for the processing of personal data

The purpose for the processing of personal data is to provide a Ticket Restaurant meals card.

The legal basis for the processing of personal data is Article 6 (1) (b) of the Regulation on the protection of individuals with regard to the processing of personal data and on the free movement of such data, repealing Directive 95/46 / EC (General Data Protection Regulation) (hereinafter referred to as the GDPR Regulation).

#### 2.1.3. Recipients of personal data

## 2.2. Retention period of personal data

Personal data will be stored during the use of the Ticket Restaurant meal card and subsequently for a period determined directly by the applicable law or in accordance with applicable law (e.g. Accounts, Archives and Registers Act).

### 2.2.1. The necessity of processing personal data

Processing of personal data is a contractual requirement, as it is necessary for the purpose of using the Edenred Dovolenka holiday card.

## 3. Meal card user's rights associated with the processing of his or her personal data

The user as a person concerned has the right to request access to personal data, the right to repair or edit personal data, to limit the processing of personal data, the right to object to the processing of personal data and the right to transfer personal data.

If a user, such as the person concerned, considers that his/her rights established by the GDPR Regulation or other relevant legislation on the protection of personal data are directly affected, he/she has the right to apply to the Personal Data Protection Authority of the Slovak Republic.
